MINUTES OF THE HISTORIC PRESERVATION COMMISSION REGULAR MEETING OF NOVEMBER 27, 2012 THE CITY OF STARKVILLE, MISSISSIPPI

The Historic Preservation Commission of the City of Starkville, Mississippi held its regular meeting in the Conference Room in City Hall, located at 101 E. Lampkin Street. Present were Commissioners Michael Fazio, Briar Jones, Jason Barrett, Tom Walker and Maxine Hamilton. Commissioners Joy Day Greene and Cyndi Sullivan were absent. Chairman Fazio called the meeting to order at 5:35 PM. Attending the Commissioners was Interim Department Head Lynn Spruill.

AN ORDER APPROVING THE WRITTEN AGENDA

The Commission considered the matter of approval of the written agenda dated November 27, 2012. Commissioner Jones made a motion to approve the agenda. Commissioner Hamilton seconded the motion and the Commission voted unanimously to approve the written agenda.

AN ORDER APPROVING THE MINUTES OF THE OCTOBER 23, 2012 MEETING

The Commission then considered the matter of approval of the minutes of the October 23, 2012 meeting. Commissioner Jones made a motion to approve the minutes as presented. Commissioner Walker seconded the motion and the Commission voted unanimously to approve said minutes as presented.



Chairman Fazio asked if any member of the public cared to address the Commission and no public comments were received.


DISCUSSION OF OLD BUSINESS

- A. There came before the Commission a discussion of the proposed changes to be made in the Greensboro and Overstreet District maps that will be submitted to the public.
 1. There was discussion by the Commission regarding the properties deleted from the Greensboro District. The suggestions from the Commissioners were to remove parcels on the map as presented with no further additions or deletions. There was a motion made by Commissioner Walker to accept the Greensboro Historic District as presented and amended, and a second made by Jason Barrett. There being no further discussion, the motion to accept the Greensboro District with the deletions as represented on the attached map was unanimously approved.

Greensboro Street Historic District




- Property Lines
- Historic District




2. Next there came before the Commission the discussion of the properties proposed to be added to or removed from the Overstreet District.
 - a. There came a discussion to remove addresses 103, 104 and 105 located on McKinley Street from the proposed historic district. Commissioner Jones moved to remove addresses 103, 104 and 105 McKinley Street from the proposed Overstreet Historic District. The motion was seconded by Commissioner Barrett and with no further discussion; the motion was approved by unanimous vote of those in attendance.
 - b. There came a discussion to remove parcels represented by alphabet letters B & C on the proposed map. The discussion was of the nature of the parcels in that they were railroad property and did not enhance the district and were logical areas to exclude. Commissioner Jones made a motion to delete the parcels represented by the letters B & C per the map under consideration; there was a second by Commissioner Hamilton and with no further discussion, the matter was put to a vote which resulted in a unanimous favorable vote of those in attendance.
 - c. There came a discussion to remove parcels represented by alphabet letter D and to add parcels represented by alphabet letter E to the proposed Overstreet Historic District. The discussion clarified the location of the properties that were represented by the letters D and C; letter D representing four (4) properties fronting Worley Street and E representing two (2) properties fronting Hogan Street midblock. Commissioner Jones moved to delete the parcels represented by the letter D and to add the parcels represented by the letter E. The motion was seconded by Commissioner Walker and with no further discussion the matter was put to a vote which resulted in a unanimous favorable vote of those in attendance.
 - d. There came a discussion to include parcels represented by alphabet letters F and G to the proposed Overstreet Historic District map. The discussion considered the nature of the parcels and their significance and integrity to the district as a whole. Commissioner Walker made a motion to include the parcels represented by the alphabet letters F and G to the proposed Overstreet Historic District map. Commissioner Jones seconded the motion and with no further discussion the matter was put to a vote which resulted in a unanimous favorable vote of those in attendance.
 - e. There came a discussion to include a parcel represented by the alphabet letter H. The discussion was centered on why the section of the parcel was excluded from the original map. Commissioner Hamilton moved to include the section of the parcel labeled as H into the proposed Overstreet Historic District. The motion was seconded by Commissioner Walker and with no further discussion the matter was put to a vote which resulted in a unanimous favorable vote of those in attendance.

Overstreet School Historic District




— Property Lines
 - - - - - Historic District




YELLOW - ADDITION




Greensboro Historic District

The Greensboro Historic District runs along Greensboro Street from 607 Greensboro Street to 305 Greensboro Street encompassing the all of the properties fronting the south side of Greensboro Street to include an additional parcel #102B-00-009.00 located behind 309 Greensboro Street. The Greensboro Historic District also runs along the north side of Greensboro Street from 606 Greensboro Street to include 302 Greensboro Street consisting of all properties fronting Greensboro Street.

Nash Street Historic District






Nash Street Historic District

The Nash Street Historic District runs along North Nash Street from University Drive to 108 N. Nash Street on the west side of North Nash Street; and along North Nash Street from 108 N. Nash Street to College View Street along both sides of North Nash Street.

Boundary Description

The Overstreet Historic District runs along South Washington Street on the western side of the street from 202 S. Washington Street south to 516 South Washington ending at West Wood Street; on the eastern side of South Washington from 213 South Washington to 525 South Washington; both sides of South Lafayette Street from 302 South Lafayette Street to East Wood Street; both sides of South Jackson Street from 301 South Jackson to 601 South Jackson Street on the east side and from 300 to 520 on the west side of South Jackson Street; 300 & 302 Worley Street; and both sides of South Montgomery Street from 200 South Montgomery Street to East Gillespie Street and from 209 South Montgomery to East Gillespie.

The Overstreet Historic District also includes 101 McKinley Street; both sides of West & East Gillespie Streets from South Washington Street to South Montgomery Street; both sides of Green Street from South Jackson Street to South Montgomery Street; and the south side of Hogan Street from South Jackson Street to South Montgomery Street; the north side of Hogan Street from 307 Hogan Street to South Montgomery Street. The district also includes 204 and 206 Wood Street located on the south side of Wood Street and all Wood Street addresses located on the north side of between South Jackson and South Washington Street.
