Present were Mayor Lynn Spruill, Aldermen Sandra Sistrunk, David Little, Hamp Beatty, Roy A'. Perkins and Henry Vaughn, Sr. as well as Deputy Clerk Leanne McGarr. Alderman Ben Carver and City Attorney Chris Latimer attended telephonically.

The meeting was properly noticed pursuant to Miss. Code Ann §§21-3-21 and a copy of that notice is included in the minutes. The public and media were welcomed and attended.

After determining there was a quorum, Mayor Lynn Spruill called the meeting to order.

1. A MOTION TO OVERRIDE THE MAYOR’S VETO OF JUNE 22, 2021.

Alderman Little offered a motion to override the Mayor’s veto of June 22, 2021, pursuant to MS Code Section 21-3-15, relating to the Board of Alderman’s vote during its June 15, 2021, Recess Meeting to ban and prohibit Bird scooters, and any other upright, motorized, public commercial scooter devices where individuals stand to ride, from the city’s streets, sidewalks, right-of-way, and any other public places, effective immediately. Alderman Beatty seconded the motion and after discussion by the Mayor and all Board members, the Board voted as follows:



Be advised that pursuant to **MS Code section 21-3-15**, this is formal notice that I veto the Motion presented by Alderman David Little, seconded by Alderman Hamp Beatty, which was passed at the June 15, 2021 Recess Meeting of the Starkville Board of Aldermen the motion being:

A MOTION TO BAN AND PROHIBIT BIRD SCOOTERS, AND ANY OTHER UPRIGHT, MOTORIZED, PUBLIC COMMERCIAL SCOOTER DEVICES WHERE INDIVIDUALS STAND TO RIDE, FROM THE CITY'S STREETS, SIDEWALKS, RIGHT-OF-WAY, AND ANY OTHER PUBLIC PLACES, EFFECTIVE IMMEDIATELY.

The motion made by Alderman David Little duly seconded by Alderman Hamp Beatty, was put to vote with the results as follows:

After receiving a majority of the affirmative vote, the Mayor declared the motion carried on June 15, 2021.

I believe that the Board's action on this date was an immoderate response to issues that a new, commercialized mode of transportation has brought to our community. While I acknowledge the concerns related in the fact finding are valid, I do not believe that an outright ban is the measured approach to this business's efforts to establish a presence in Starkville. This business and numerous others of the same nature are operating in multiple other communities throughout the country and with appropriate restrictions tailored to the community impacted I believe they should be allowed to continue to operate in the city limits of the City of Starkville.

The Board had previously expressed concerns over the use of the scooters in locations that were inherently dangerous such as MDOT Highway 12. The company has responded by geofencing off the ability of the scooters to access Highway 12. They have likewise geofenced off the ability of the scooters to access the campus of Mississippi State University.

The speed of the scooters was also considered a concern and the scooters are regulated at 15 mph. The company has also created slow zones in areas designated as congested so that the scooters will be reduced further in their speed.

The studies that have been conducted by independent agencies have determined the accident/incident rate for scooters is the equivalent to that of bicycles and results in less than .001% of trips taken. There will never be an absolute for safety no matter the form of transit and it is relevant that this is no different than bicycles which are welcomed on our streets and multi-use paths. There is a local and statewide program for sharing the road with bicycles which can easily be an awareness for the same sharing concept with scooters in an urban environment.

We as a city have worked to offer many options for transportation to our citizens and this is one of those methods. Recognizing that there is an inherent element of danger in the later hours when scooters are harder to see, the company in question has the ability to shut them down at a given time and so will implement a scooter curfew. I will note that we have no such curfew on bicycles which are even harder to detect at night.

There has also been expressed concern for the random nature of the locations where the scooters are being placed and the haphazard way they are left around town. The company has a method by which they can encourage those using the scooters to return them to the "nests" to reduce the frequency of clutter in leaving them scattered around town.

While there are many ways that I concur in our alignment approach to policies shared by Mississippi State University, there are others that while they do not necessarily fit the university, they are quite acceptable for the city. This is one of those that will not create any issues for either entity since the University is geofenced from the operation of the scooters.

Scooter company statistics since the arrival of the company:

There have been over 8,900 rides taken.

There are two small business owners who are working to manage these scooters.

They have enabled 484 regular commuters to get to and from work/school.

Had users travel 19,190 miles on scooters, reducing traffic and offsetting CO2 emissions.

Had 3,070 unique users (roughly 12% of the resident population of the city).

Had roughly 60% of trips end in front of a small business, driving additional spending and traffic within them.

It is for these reasons that I believe it is in the best interest of our overall community to allow the commercial use of scooters to continue in the city limits and to continue to work with the company to regulate their use to enhance the safety and allow for alternative transit uses as well as recreational ones.

I will be bringing forward a draft ordinance to address the matter of scooters and will work with the company to craft a contract or memorandum of understanding for their operation within our city limits designed to maintain the health, safety and welfare of our traveling public. There is a local and statewide program for sharing the road with bicycles despite the similarities in the use and rates of accident or incidents.
